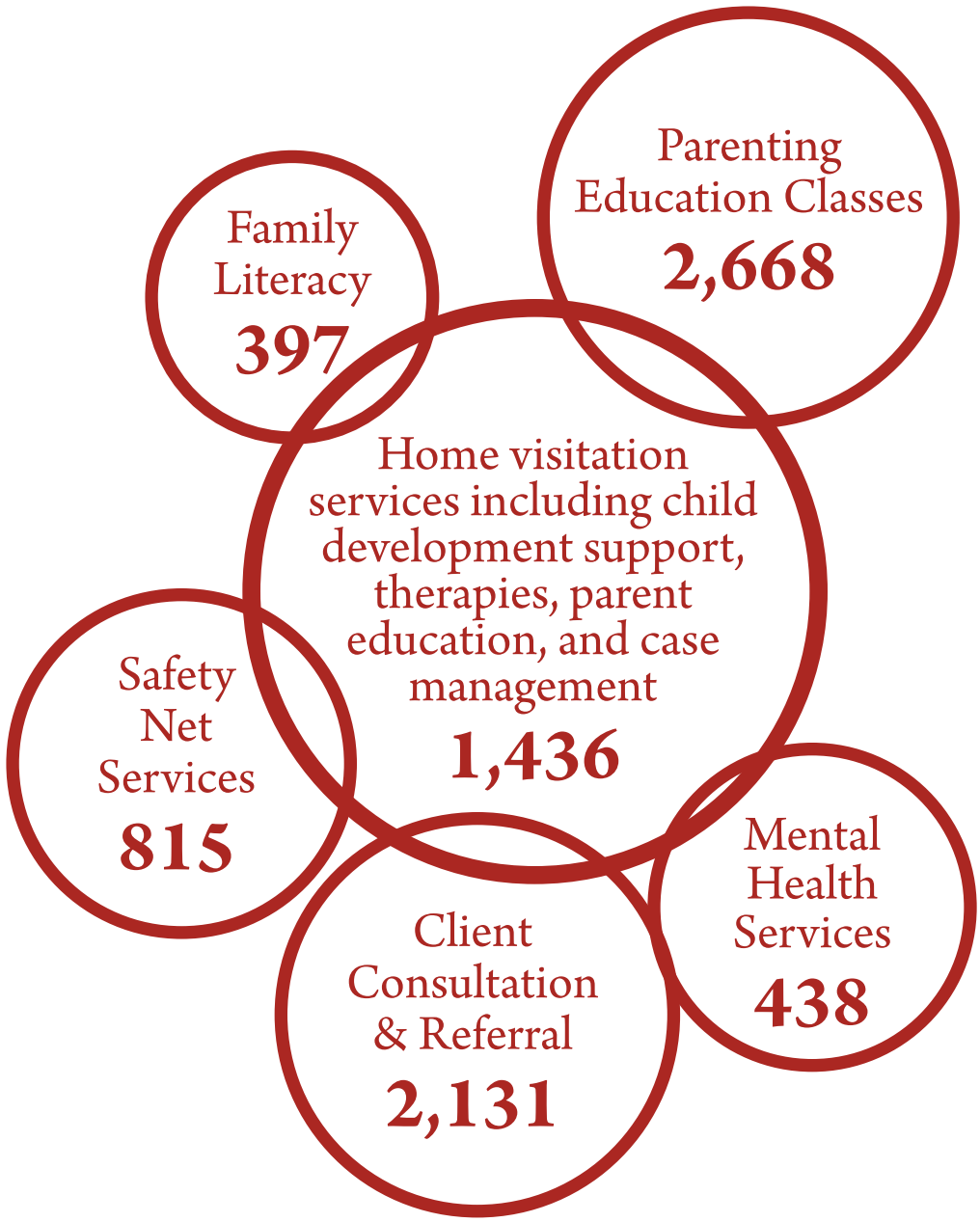

Numbers reflect children and families served by area.

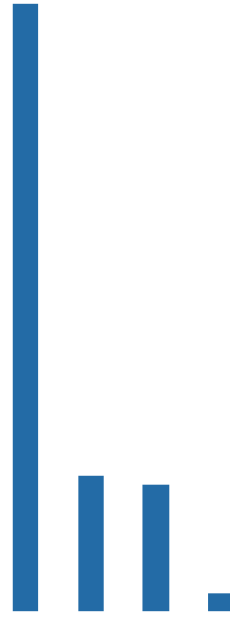

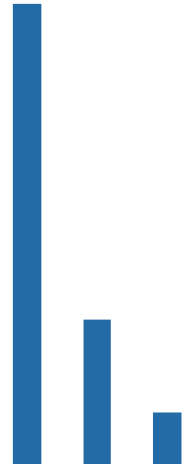
